SUBJECT: APRIL 1999 Basic calculations for Equalization Assistance Report (APOR 55-1), Formula for Growth in Student Count (APOR 55-2), and Equalization Assistance and Additional State Aid Detail Report (APOR 64)

Enclosed you will find the APRIL 1999 apportionment reports for your school district. These reports reflect data used to calculate the FY 1998-99 Revenue Control Limit, Capital Outlay Revenue Limit, Capital Levy Revenue Limit, and Equalization Assistance. In addition to the allocation of equalization assistance, the payments for APRIL may include Secured and/or Unsecured Additional State Aid, and the allocation of County Equalization.

Also enclosed you will find the Apor 55-2, Formula for Growth in Student Count report. This report is based on final 40th day Average Daily Membership (ADM) and Special Education counts submitted by your district as of April 5, 1999. Growth forms based on the final 100th day ADM and Special Education counts will be mailed to each district the week of April 12th. Included with this will be the Fiscal Year 1998-99 Growth Statement of Action form. In order to receive the additional funds and/or budget capacity for growth your district board must revise its budget, page 5 of 6, line 1b, to include an amount equal to or less than the growth amount calculated by the ADE. The "Growth Statement of Action" form must be received by the ADE no later than May 31, 1999 in order to receive the funds on the 6/15/99 payment.

For Type 03 districts, the Type 03 Tuition Out adjustment forms were mailed out the first week of April. In order to have your apportionment correctly reflect your Fiscal Year 1998-99 Tuition Out values your district board must revise its budget, page 5 of 6, line 1 c, to increase or decrease the originally budgeted tuition out figure. The "Type 03 Tuition Out Adjustment form" must be received by the ADE no later than May 31, 1999 in order to receive the funds on the 6/15/99 payment.

If you have a question on any of the data simply copy the report and return it to us with the data in question circled. These reports are for your information and DO NOT require district sign off.
